The Silent World Among the people with disabilities, the Deaf is a unique group of people. Because lack of the *ability to hear, they have difficulty* in speech. Due to communication barrier, deaf people face a lot of challenges; education, employment, mental health, self-esteem, and performing some activities in everyday life that many hearing people take for granted. Except loss of hearing, they function 100% like hearing people. Respect, Understanding, and Support not sympathy are meaningful and treasure to these people group. The speaker will discuss his experience assisting with the needs of the Deaf in China.
