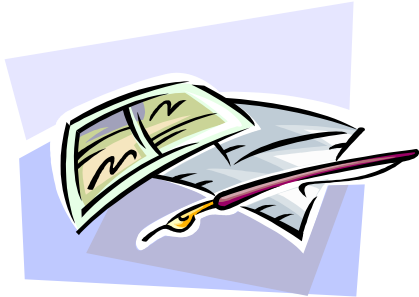

Use the acronym 'DOTWIMP' to remember the 7 Wastes of Lean. The worst of all the 7 wastes is overproduction because it includes in essence all others and was the main driving force for the Toyota JIT system. They were smart enough to tackle this one to eliminate the rest.

Section 509 has had a Software Special Interest Group (SIG) for several years. It went into hiatus once or twice, but it has been back on a regular basis since last May. The purpose of the Software SIG is to provide software quality professionals and software professionals interested in quality with an opportunity for growth and exchange of ideas with other software professionals, and to facilitate growth in the number and expertise of the ASQ membership. Where the ASQ Software Division provides indirect interaction at a national level through its Software Quality Professional journal and its web page, the Software SIG provides local direct interaction through its meetings.

Members of the ASQ Software SIG include software quality professionals, software engineers, and others interested in applying quality principles to the field of software development. We have a web page at:

The primary focus of the Software SIG is the bi-monthly meetings where you will get to network with other professionals interested in software quality and hear a presentation on some aspect of software quality. Any topic at the intersection of quality and software is fair game. We pay special attention to the Software Quality Engineer Certification (CSQE) Body of Knowledge
